

# 7th ANNUAL GOOD FOR HER FEMINIST PORN AWARDS OFFICIAL RULES

NO FEE OR PURCHASE NECESSARY TO ENTER OR WIN.  
A FEE PAYMENT OR PURCHASE WILL NOT IMPROVE THE CHANCES OF WINNING.

Thank you so much for your interest in submitting an entry to the 7th ANNUAL GOOD FOR HER FEMINIST PORN AWARDS (the "Awards"). The announcement of the winning films, including the finalist films, will take place at the Berkeley Church on April 20th.

**1. GENERAL CONDITIONS:** The Awards are being sponsored by Good For Her and co-sponsors (each a "Co-Sponsor") identified on the official Good For Her Feminist Porn Awards page of Good For Her's website at [http://www.goodforher.com/fpa\\_2012](http://www.goodforher.com/fpa_2012) (the "Awards Site"). Those who enter the Awards agree to abide by the terms of these Official Rules and by the decisions of Good For Her and the Judges.

**2. ELIGIBILITY:** The Awards are open ONLY to natural persons who are 18 years of age or older at the time of entry. Employees of Good For Her are not eligible to enter the Awards. Good For Her will only accept entries completed and submitted in the format designated below.

**3. WHAT TO SUBMIT:** Each person entering the Awards (each, an "Entrant") may submit more than one film entry (an "Entry").

- Entries that are not accepted into the Awards WILL NOT be returned. Entrants are responsible for including opening and closing credits as part of their Entries.
- Entry contents can be anything that reflects eroticism. Entries can be serious, light-hearted, romantic, etc. Entries can also be animated, pixilated, or digitally enhanced to reflect creativity. Entries CANNOT feature, show, or in any way have any model, actor, actress or other participant (each a "Film Participant") who is under the age of 18 associated – NO EXCEPTIONS!
- Entries must be submitted in DVD formats or via the web for online entrants. Good For Her reserves the right to disqualify any Entry not in the format specified herein.
- All entries become the property of Good For Her upon submission. No Entry will be returned upon completion of the Awards. Entrants should make copies of his/her Entry prior to submission in order to have his/her Entry's record.
- Good For Her will have no responsibility for, and will have the right to refuse in its sole and absolute discretion, any copies of submitted Entries, Entries that have been tampered with, or Entries that are misdirected, incomplete, non-conforming, corrupt, lost, late, or ineligible, for any reason. In the event of a dispute regarding who submitted an Entry, the Entry will be deemed to have been submitted by the person specified in the Good For Her Agreement and Release that will be signed by each Film Participant in a particular Entry (as set forth in the following paragraph).

**4. HOW TO SUBMIT:** To enter the Awards, Entrants must submit 4 copies of each submission together with the Submission Form (found at the end of this document) for each title. The Entry together with the proper documentation can either be:

Please send all Entries in a sealed envelope.

(b) Can be submitted in person at our retail location at the same address above.

If available, entrants may also include press materials, artist statements, still images (print or on CD) or other information that might be helpful for both jury members or for press use.

**PLEASE NOTE: For Entries originating outside of Canada, senders must mark on the customs declaration form that the submission is a sample, and has a value of ZERO. Submissions that incur customs fees/duty will be refused and will not be entered into the Awards.**

**Each submission must be accompanied by a completed and signed submission form (please find at the end of the rules and regulations)**

**5. WHEN TO SUBMIT:** All Entries MUST be received no later than February 17, 2012 5pm Eastern Time. Entries will not be accepted after this date – NO EXCEPTIONS!

**6. JUDGING:** Entries are judged by members of the Good For Her Feminist Porn Award organizing committee as well as jury members from the community. Committee and jury members' decisions are final and not subject to appeal.

**7. ANNOUNCEMENT; WINNER/FINALISTS:** The announcement of winners of the Awards will occur on Friday, April 20th at the Berkeley Church in Toronto. Press releases announcing the winners will be sent on Monday April 23rd.

**8. PRIZES:** No substitutions of prizes or cash exchanges are permissible, except that Good For Her reserves the right to substitute a prize in its sole discretion. Prizes will be handed out at the Berkeley Church on April 20th. Good For Her endeavors to send trophies, certificates or other proof of award to the winners within 6 weeks of the awards.

The prizes awarded at the Awards carry no cash value.

**9. REPRESENTATIONS; LICENSE:** By entering the Awards, each Entrant represents and warrants that: (a) the Entrant meets all eligibility requirements of the Awards; (b) in entering and participating in the Awards, the Entrant has complied and will comply in all respects with these Official Rules and all applicable statutes, regulations, and other laws, including without limitation the requirements of 18 U.S.C. §2257, (c) the Entry consists entirely of the Entrant's own original work in which the Entrant holds all rights, including without limitation copyrights, trademark rights, and rights of publicity, necessary for Entrant's participation in the Awards and for Good For Her' and Co-Sponsors' use in connection with the Awards; (d) neither the Entry nor the duplication, distribution, display, performance, use, or other exploitation of the Entry will infringe or misappropriate any intellectual property or other proprietary rights of any individual or entity, including without limitation any copyrights, trademark rights, rights of publicity, or privacy rights; and (e) the Entrant will not use Good For Her's or any Co-Sponsor's name, trademark, logo or other information of Good For Her or a Co-Sponsor in connection with the Entry or in connection with any other film, including without limitation in connection with the Entry's promotion, performance (other than in the Awards), or commercial exploitation. By entering the Awards, each Entrant grants to Good For Her an irrevocable, royalty-free, perpetual, right to edit, publicly display, perform, and use the Entry in connection with the Contest.

**10. RELEASE:** To the maximum extent permitted by law, by entering the Awards, each Entrant releases and holds harmless Good For Her, any Co-Sponsors, and each of their respective parents, subsidiaries, affiliates, officers, directors, employees, agents, and representatives from any and all responsibility or liability (including without limitation for any injuries, losses, or damages of any kind, such as compensatory, direct, incidental, consequential, punitive, or other damages) arising out of or relating to: (a) the Awards or the showing of any film entered in the Awards; (b) the acceptance, possession, receipt, or use of any prize; (c) any Entries that have been tampered with or that are misdirected, incomplete, non-conforming, corrupt, lost, late, or ineligible; (d) computer, telephone, cable, satellite, network, hardware, or software malfunctions or failures; garbled or jumbled transmissions; or Internet or website accessibility or delays, including without limitation any malfunctions occurring while showing the Entries at any theatre; (e) printing or typographical errors in any Awards-related materials; or (f) any other technical or human errors occurring in connection with the Awards. THE PRIZE WILL BE GIVEN AWAY BY GOOD FOR HER AND/OR CO-SPONSORS "AS IS."

**11. TERMINATION:** To the maximum extent permitted by applicable law, Good For Her reserves the right to suspend, modify, or terminate the Awards at any time prior to the Decision Date for any reason, in its sole and absolute discretion, including without limitation in the event of fraud or technical or other difficulties. In such cases, Good For Her will post notice on Good For Her's website at [http://www.goodforher.com/fpa\\_2012](http://www.goodforher.com/fpa_2012).

**12. ADVERTISING:** By entering the Awards, each Entrant consents to the use by Good For Her information related to the Awards for advertising, marketing or other purposes. If you are selected as a finalist we will request and use your name (legal or stage name), photo, and short bio for our program and promotion without additional compensation.

**13. NO ENDORSEMENT:** Nothing contained herein or in any of the Awards related materials should be construed as an endorsement by Good For Her or Co-Sponsors of the prize manufacturers, or any third party, product, or service.

Entrants who violate these Official Rules, tamper with the operation of the Awards or engage in any conduct that is detrimental or unfair to Good For Her Inc., the Awards or any other entrant (in each case as determined in Good For Her Inc.'s sole discretion) are subject to disqualification from entry into the Awards. Good For Her reserves the right to prohibit participation in the Awards of persons whose eligibility is in question or who have been disqualified or are otherwise ineligible to enter the Awards.
